Riverview Intermediate Unit

#### Math

- Pull-out small group direct instruction, supplemented by consultation with the classroom teacher and/or Push-in during small group instruction time in the general education classroom
- Diagnostic and benchmark assessments and progress.
- Targets skill remediation for students performing below grade level
- Emphasis on early intervention in primary grades (also available in upper grades)

# Math/STEM Coach

- Provides training to teachers in the area of mathematics and STEM
- Coaches teachers to transfer best practices into classroom practices
- Provides resources relating to new techniques and practices in mathematics and the use of technology
- Assists teachers in specific matters of curriculum development, instructional improvement, and assessment strategies in Mathematics and Technology



Consultation Services are provided to teachers in nonpublic schools to assist in educating students with special needs. Evidence that a student meets disability criteria must be presented. The consultant works with teachers to design appropriate accommodations for each student. The accommodations and/or specific strategies can focus on issues that are academic, social, or behavioral.

### **Social Worker**

- Individual or small group sessions
- Intended to improve a student's overall performance and ability to participate appropriately in their educational setting
- Enhancement of social skills, emotional regulation/coping strategies, self-esteem, emotional well-being, and executive functioning
- Provides assistance to families within the school to set up services in the home if needed



# Reading

- Pull-out small group direct instruction, supplemented by consultation with the classroom teacher and/or Push-in during small group instruction time in the general education classroom
- Diagnostic and benchmark assessments and progress.
- Targets skill remediation for students performing below grade level
- Emphasis on early intervention in primary grades (also available in upper grades)
- Coordinated with Title I reading intervention where applicable

## Speech and Language



- Provided by PA-certified speech/language therapists (primarily in grades K-6 but later grades as needed)
- Typically, conducted individually and/or in small groups
- Therapy provided for speech and/or language difficulties

#### **Enrichment**

- Pull-out sessions on topics of interest and challenge students
- Available in grades three through six
- Offered if sufficient need and schedule availability allows.
